Expression of Interest for Empanelment of Academicians

Introduction:

M/s Intelligent Communication Systems India Limited (ICSIL), is a joint venture of Telecommunications Academicians India Ltd. (TCIL), A Govt. of India Enterprise under Ministry of Communications and Delhi State Industrial & Infrastructure Development Corporation Ltd. (DSIIDC), an undertaking of Govt. of NCT of Delhi.

Background & Objective:

ICSIL has ventured into IT and Vocational education to create skilled manpower in the country. ICSIL has large number of franchisee centers in the country to run IT courses for the purpose of Knowledge enhancement of intended persons. ICSIL has been running IT courses (presently around 465 No's) since 1997 under TCIL-IT education and training program. ICSIL runs and manages around 130 training centers on behalf of TCIL (including addition and alteration of courses), opening of new branches directly or through its subagent(s).

ICSIL intends to empanel and hire Academicians for review of present IT courses as well as designing and delivery of new IT courses to be run in future through ICSIL franchisee centers for aspirants.

Scope of work: Broad scope of work for the Academicians would be as mentioned below:-

- 1. To analyze course content (present as well as new ones) so received from the franchisees, submit recommendation/advice to ICSIL within 10days of receipt, after which ICSIL may give approval/ go ahead to franchisees to run that course in their institutes.
- 2. Suggest methodology for charging of training fee to potential candidates that should be reasonable and affordable vis-à-vis other programs being conducted by other institutes.
- 3. To give recommendation for new IT training courses based on present and future market trends.
- 4. Prepare contents of new programs/courses.
- 5. Also suggest time table for franchisees to run such programs.
- 6. Also plan/design infrastructure for franchisee centers.
- 7. Conduct audit of centers and suggest corrective and preventive action.
- 8. Plan and design online training IT programs.
- 9. Examination and Testing criteria for each IT-program (Question papers and questionnaire for interaction/interview to qualify candidates for obtaining certificates)
- 10. Prepare a comprehensive report on IT courses being/ to be run.

- 11. Also to see any legal/statutory compliance is required to run such IT courses from concerned government agency.
- 12. Any other relevant matter that is not covered above but may be required.

Empanelment will be valid for at least one year which may be reviewed by ICSIL as and when required.
