SECTION-II: INSTRUCTION TO BIDDERS (ITB)

A: The Bidding Documents

1. Cost of Bidding

a) The Bidder shall bear all costs associated with the preparation and submission of its bid and ICSIL hereinafter referred to as "the Purchaser", will in no case be held responsible or liable for these costs, regardless of the conduct or outcome of the bidding process.

2. Content of Bidding Documents

2.1 The goods required, bidding procedures and contract terms are prescribed in the bidding documents. The bidding documents include:

a. Section I : Tender Time-lines

b. Section-II : Instructions to Bidders (ITB)

c. Section-III : Conditions of Contract

d. Section-IV : Technical Bide. Section-V : Financial Bid

2.2The Bidder is expected to examine all instructions, Forms, terms and specifications in the bidding documents. Failure to furnish all information required by the bidding documents or submission of a bid not responsive to the bidding documents in every respect will be at the Bidder's risk and may result in rejection of his bid.

3. Amendment of Bidding Documents

- 3.1 At any time prior to the deadline for submission of bids, the Purchaser may, for any reason, whether at its own initiative or in response to a clarification requested by a prospective bidder, modify the bidding document by amendments. Such amendments shall be posted/ uploaded on the website of ICSIL i.e. http://icsil.in/tenders through corrigendum and shall form an integral part of bid documents. The relevant clauses of the bid documents shall be treated as amended accordingly.
- 3.2 It shall be the sole responsibility of the prospective bidders to check the web site http://icsil.in/tenders from time to time for any amendment / corrigendum / clarification pertaining to the tender document. In case of failure to get the amendments, if any, the purchaser shall not be held responsible.
- 3.3 In order to allow prospective bidders a reasonable time to take the amendment into account in preparing their bids, the Purchaser, at his discretion, may extend the deadline for the submission of bids. Such extensions shall be posted/up-loaded on the website http://icsil.in/tenders.

B: Preparation of Bids

1. Language of Bid

1.1The bid prepared by the Bidder, as well as all correspondence and documents relating to the bid exchanged by the Bidder and the Purchaser, shall be written English language.

2. Documents Constituting the Bid

The bid prepared by the Bidder shall comprise the following components:

- (a) **Technical Bid** Technical Bid will comprise of:
 - (i) Fee Details Tender Fee and Bid Security i.e. EMD
 - (ii) <u>Qualification Details</u> includes copies of required documents justifying that the Bidder is qualified to perform the contract if its bid is accepted and that the bidder has financial, technical and production capability necessary to perform the contract and meets the criteria outlined in the Qualification Requirement and Technical Specification and fulfill all the conditions of the Contract and that the goods and ancillary services to be supplied by the Bidder conform to the bidding documents and Technical Specifications.

3 Prices

Prices quoted by the Bidder shall be firm during the Bidder's performance of the Contract and not subject to variation on any account. A bid submitted with an adjustable price, quotation unless asked for shall be treated as non-responsive and rejected.

4. Bid Currencies

Prices shall be quoted in Indian Rupees only.

- 5. Documents Establishing Bidder's Qualification
- 5.1 The Bidder shall furnish, as part of its Technical Bid, documents establishing the Bidder's qualification to perform the Contract if its bid is accepted.
- 5.2 The documentary evidence of Bidder's qualification to perform the Contract if its bid is accepted shall be as per Qualification Requirements specified in Section-III Annexure-D i.e. Compliance to Eligibility Criteria of tender document.

6.0 Documents Establishing Goods' Conformity to Bidding Documents

- 6.1 Pursuant to ITB the Bidder shall furnish, as part of its bid, documents establishing the conformity to the bidding documents of all goods and services which the Bidder proposes to supply under the contract.
- 6.2 The documentary evidence of conformity of the goods and services to the bidding documents shall consist of:

- (a) The brochures/leaflets/the document downloaded from the internet site of the OEM of the goods offered in support of the technical specifications asked in the tender.
- (b) An item-by-item commentary on the Purchaser's Technical Specifications demonstrating substantial responsiveness of the goods and services to those specifications or a statement of deviations and exceptions to the provisions of the Technical Specifications;
- (c) A confirmation that if the Bidder offers systems and/or other software manufactured by another company, such software operates effectively on the system offered by the Bidder; and the Bidder is willing to accept responsibility for its successful operations.
- (d) A confirmation that the Bidder is either the owner of intellectual Property Rights in the hardware and the software items offered, or that it has proper authorization from the owner to offer them. Willful misrepresentation of these facts shall lead to the cancellation of the contract without prejudice of other remedies that the Purchaser may take.

7.0 <u>Technical and Financial Bid:</u>

D. Cover-1: Technical Bid:

ii) Documents as required in the Tender shall be submitted in this envelope. The envelope should be sealed and superscripted "Technical Bids". Financial Bid should not be submitted in the Technical Bid, failing which the bid will be rejected.

E. Cover-2: Financial Bid:

- i. The envelope shall be sealed and superscripted "Financial Bid". The financial bids of technically qualified bidders only shall be opened.
- ii. The above two envelopes shall be placed in one outer cover superscripted "ICSIL Tender for IT Products for DTTE". The outer cover shall be submitted to the office of General Manager (IT), ICSIL on or before 16/09/2013 by 2:30 PM i.e. by the last date and time of submission of the bid.
- iii. **Tender Processing Fee:** The bidders should submit a non-refundable Tender Processing Fee of Rs.2000/- (Rupees Two Thousand Only) in the form of Bank Demand Draft / Pay Order Payable to ICSIL, Delhi.
- iv. **EMD:** All bidders must submit unconditional and irrevocable EMD in the form of Bank Guarantee **for an amount of Rs.6,00,000/- (Rupees Six Lakh Only)** issued by a nationalized commercial bank valid for a period of 180 days from the date of issue in favor of Intelligent Communication Systems India Limited, Delhi. - vi. Financial Bid of only those bidders who are found qualified in technical bid will be opened for evaluation.

vii. The work order shall be awarded to lowest quoted firm. Final decision in this regard shall vest with ICSIL.

8. Release of EMD:

- i. EMD of unsuccessful bidders will be released immediately once the work order is placed on the successful bidder.
- ii. EMD of Successful bidders shall be returned after the work order is awarded and the equipment is installed and accepted by the client department. A certificate to this effect shall be obtained by the vendor from the client and submitted to ICSIL in order to facilitate release of EMD.
- iii. A request for release of EMD should come to ICSIL in writing along with an undertaking as per format given in Section-III, Annexure-"K".

9. Forfeiture of EMD/Performance Guarantee:

1. EMD can be Forfeited under the following circumstances:

- a. If the bidder withdraws its bid during the period of bid validity or after last date of submission of bid.
- b. Fails to execute the work order within given time
- c. Furnishes wrong information,
- d. Does not accept the correction of errors in accordance with the Instruction to Bidders or
- e. Modifies its bid price during the period of bid validity specified by the bidder or

2. if the Bidder, having been notified of the acceptance of its bid by the Purchaser during the period of bid validity:

- (a) fails or refuses to execute the Contract Form within the prescribed period, if required; or
- (b) fails or refuses to furnish the performance security within the prescribed period in accordance with the Instructions to Bidders;
- (c) In case the bidder fails to complete the assigned work within the prescribed time period.

10. Validity of Tender:

The Tender is valid for a period of six months (i.e.180 days) from the last date of submission of the bid. The validity time may be extended by ICSIL.

11. Validity of Rates:

The rates are valid for a period of 12 month i.e. one year from the date of issue of work order.

12.Late Bids:

Late bids will not be accepted. Once the bid submission date and time is over, the bidder cannot submit his/ her bid. The bidder will only be held responsible if his/ her bid is not submitted in time.

13.Bid Opening and Evaluation of Bid:

13(A)Opening of Technical Bids by the Purchaser:

- 13.1 The Purchaser will open all technical bids, in the presence of Bidders' representatives who choose to attend at 3:00 P.M. on 16/09/2013. The Bidder's representatives who are present shall sign a register evidencing their attendance. In the event of the specified date of Bid opening being declared a holiday for the Purchaser, the Bids shall be opened at the appointed time and location on the next working day.
- 13.2 The bidder's names, bid modifications or withdrawals and the presence or absence of requisite bid security and such other details as the Purchaser at its discretion may consider appropriate, will be announced at the opening. No bid shall be rejected at the time of bid opening.
- 13.3 The purchaser will prepare minutes of the bid opening.

13(B) Opening of Financial Bids:

- i) After the evaluation of technical Bid, the Purchaser shall notify those Bidder whose technical Bid were considered non-responsive to the conditions of the Contract and not meeting the technical specifications and Qualification Requirement indicating that their financial bid will not be opened. The Purchaser will simultaneously notify the Bidder whose technical Bid were considered acceptable to the Purchaser indicating the date, time and place for opening of the financial Bids. The notification may be sent by registered letter or by electronic mail.
- ii) The financial Bid shall be opened in ICSIL on the notified date in the presence of Bidders who choose to attend. The name of Bidders, unit price quoted for various items etc will be announced at the meeting.
- iii) The Purchaser will prepare the minutes of the Bid opening.

14. Clarification of Bids:

14.1 During evaluation of bids, the purchaser may, at its discretion, ask the bidder for a clarification of its bid. The request for clarification and the response shall be in writing and should be submitted latest by 06/09/2013 at the e-mail address bist.kamal@icsil.in and info@icsil.in mentioning Tender No. and relevant para of the Tender Document on which the clarification is being sought. Queries received after 06/09/2013 will not be entertained.

15. Evaluation of technical bids and Evaluation criteria:

The Purchaser will examine the bids to determine whether they are complete, whether they meet all the conditions of the Contract, whether required tender fee, bid security and other required documents have been furnished and whether the bids are generally in order. Any bid or bids not fulfilling these requirements shall be rejected.

16. Eligibility Criteria:

i. The bidder should have executed at least one single order of Hardware/Software/Networking in government organization/PSU of minimum value Rs.75.00 lac in any one of the last three financial years. The bids of the bidders not submitting duly signed & stamped evidence i.e. the copy of purchase order and satisfactory installation report given by the department/ organization shall be rejected.

- ii. The bidder/ the original equipment manufacturer of the computers quoted in the tender shall be in the business of regular supply and installation of the same make/brand of the computers since last three financial years. The bids of the bidders not submitting duly signed & stamped evidence i.e. copies of one purchase order and its satisfactory installation report per year for each of the last three financial years regarding regular supply of the same brand of computers as quoted in the bid shall be rejected. The bidders should also submit filled in Performa as per "Section III (G) Performance Statement Form" in support of his/ her experience.
- iii. All the items quoted should have minimum technical specifications given in the tender.
- iv. The bidder should either be an OEM or an authorized business partner of OEMs. In Case, bidder is a business partner of OEM, a Manufacturers Authorization certificate (MAF) from the OEM must be submitted along with the Technical Bid in respect of Desktops of this Tender.
- v. The bidder should be registered with VAT and Service Tax Department.. Copy of valid VAT, CST Registration and Service Tax Certification must be submitted in the Technical Bid.
- vi. The bidder should have Income Tax PAN in the name of the bidder firm, if it is a Company. If the bidder is a Proprietary firm, PAN should be in the name of its proprietor. Copy of PAN must be enclosed in the Technical Bid.
- vii. A self-certificate that the bidder has not been black listed by any department of the Central/State government in the past three years, is to be submitted in the Technical Bid failing which the bid will be rejected.
- viii. The bidder should have an Average Annual turnover of at least Rs.15 crore (Rupees Fifteen Crores) in the Last three Financial Years and for that purpose bidder should submit certified copies of certificates from Chartered Accountant. The bids of the bidders whose Annual Average turnover in the last three years is less than Rs.15.00 crore or who do not submit certified copies of certificates from Chartered Accountant shall be rejected.
- ix. All the items quoted should have minimum technical specifications given in the tender.
- x. The bidder should be in the business of supply and installation of the hardware, software / IT products since last three financial years. The bids of the bidders not submitting duly signed & stamped evidence i.e. copies of one purchase order and its satisfactory installation report per year for each of the last three financial years shall be rejected. The bidders should also submit filled in Performa as per Annexure-G i.e. "Performance Statement Form" in support of his/ her experience.
- xi. An undertaking by the bidder that the Rates quoted by it are not higher than the rates quoted to any other Government Department/PSU/ in past one year. A certificate to this effect should be submitted by the bidder.
- xii. Technical Bid if not accompanied by above desired documents and are not in line with tender conditions, the same would be **rejected**. .

xiii. The Supplier must have at least one service support centre in Delhi. Proof has to be submitted

17. Award of Contract:

Award Criteria

The Purchaser will determine to its satisfaction that the Bidder(s) selected having submitted the lowest evaluated responsive bid and meets the criteria specified in Instruction to Bidders and is qualified to perform the contract satisfactorily. Purchaser will award the Contract to the lowest evaluated successful bidder whose bid has been determined to be responsive to all the conditions of the Contract and meeting the Technical Specification and Qualification Requirement of the Bidding Document.

PERFORMANCE SECURITY DEPOSIT: Firm awarded with the contract shall have to deposit Performance Security equal to 5% of the total ordered value. The Performance Security should be in the name of Intelligent Communication System India Ltd., Delhi and valid for the entire contract period. Format of Performance Security Deposit is given at Section-III, AnnexureJ.

18. Purchaser's right to vary Quantities at the Time of Award:

- i. The Purchaser reserves the right at the time of Contract award to increase or decrease the goods and services originally specified in the Schedule of Requirements without any change in unit price or other terms and conditions.
- ii. If any taxes/duties are increased/reduced by the Government during the contract period the same shall be adjusted mutually after submitting the proof by the successful bidder to the purchaser.

19. Purchaser's right to accept any bid and to reject any or all Bids

The Purchaser reserves the right to accept or reject any bid, and to annul the bidding process and reject all bids at any time prior to contract award, without thereby incurring any liability to the affected Bidder or bidders.

20. Notification of Award

- i. Prior to the expiration of the period of bid validity, the Purchaser will notify the successful bidder in writing that its bid has been accepted.
- ii. The notification of award will constitute the formation of the Contract.

21. Payment Terms:

- i. No advance payment shall be made.
- ii. Payment equal to 80% of the total work order shall be released on back to back basis and that too after complete delivery and installation of all items duly certified by the client

- department. Balance 20% shall be released on back to back basis i.e. after receipt of payment from the client department.
- iii. Bill for release of payment should be submitted in triplicate along with satisfactory completion certificate from the client department for the activity/Task for which the bill is being raised. In the absence of satisfactory completion certificate from the client department, the bill for payment shall not be processed for release of payment.

22. Penalties:

- i) For delays beyond 28 calendar days from the date of issue of work order shall carry a penalty of Rs.10,000/- (Rupees Ten Thousand Only) per week delay with a cap of Rs.2,00,000/- (Rupees Two Lakhs only) of delay upto 60 days from the date of issue of work order
- ii) Forfeiture of Performance Security Deposit in case delay is beyond 60 days from the issue of work order.

23. Commercial bid:

- Bidders should quote prices as per commercial bid format given at Section-IV, Annexure-"X" i.e. Financial Bid.
- ii. Rates should contain taxes, duties and levies separately as per format given...

24. Delivery of goods:

Goods should be delivered to the destination within 3-4 weeks of the receipt of work order, failing which penalty as stated above shall be imposed. Goods are to be supplied at the client's destination FOB.

25. Warranty:

- i. The Supplier warrants that the Goods supplied under this Contract are new, unused, of the most recent or current models and that they incorporate all recent improvements in design and materials unless provided otherwise in the Contract. The Supplier further warrants that all Goods supplied under this Contract shall have no defect arising from design materials or workmanship or from any act or omission of the Supplier, that may develop under normal use of the supplied Goods in the conditions prevailing in the country of final destination.
- ii. warranty shall be comprehensive for all the equipment's, parts and components (excluding consumable items but including print heads, Drum of Laser Printers, batteries of UPS and plastic parts) and the period of warranty shall be 36 months from the date of installation and acceptance of the Goods or 39 months from the date of delivery at project sites, whichever occurs earlier. Software warranty of 90 days will be limited to replacement of media only. The supplier shall in addition comply with the performance guarantees specified under the contract. If for reasons attributable to the supplier, these guarantees are not attained in whole or in part, the Supplier shall, make such changes, modifications and or additions to the Goods or any part thereof as may be necessary in order to attain the contractual guarantees specified in the Contract at its own cost and expense.
- iii. The Purchaser shall promptly notify the Supplier in writing of any claims arising under this warranty.

- iv. During warranty period, the defective item or component shall be replaced or repaired whatever required, by the supplier or the service center authorized by the supplier, to the satisfaction of the user departments.
- v. Period for correction of defects in the warranty period is 48 hrs.
- vi. The supplier shall guarantee a 98% uptime of computer systems/peripherals and all other items.
- vii. If any items give continuous trouble say six times in one month during the warranty period, the supplier shall replace that items with new one without any additional cost to purchaser.
- viii. It shall be the responsibility of the supplier to install, configure, test and commission the hardware, software, network or any other equipment supplied by it

26. Maintenance service

- i. The maximum response time for rectification of complaint shall not exceed 24 hours.
- ii. It is expected that the average downtime of the item will be less than half the maximum downtime (i.e. 48 hours for which an item or equipment is not useable because of inability of the supplier to repair it). In case an item is not usable beyond the stipulated maximum downtime the supplier will be required to arrange for immediate replacement of the same till it is repaired. Failure to arrange for the immediate repair/replacement will be liable for a penalty of Rs. 100 per day per item. The total amount of penalty recovered from supplier during full warranty period will be limited to the worth value of the performance security guarantee. The amount of penalty will be recovered from the Performance Security Guarantee during warranty period.
