II Duties and Responsibilities

1. Sanitation of building floors by sweeping, mopping, scrubbing or vacuuming.
2. Servicing and cleaning of restrooms.

7. Set up, arrange or remove decorations, tables, chairs, ladders etc.

In case the candidate has changed his/her name subsequent to Class 10th examination, evidence to that effect should be furnished at the time of interaction/documents verification also.
4. Short listing of candidates shall be based on scrutiny of their documents in respect of age, qualification, experience etc.
5. Only short listed candidates will be allowed to appear for interaction.
