- Total numbers of OPD/IPD & Emergency Registration Counters for which services required is 09 Nos (with 13 DEO) in a day. However, number of counters may vary (<u>+</u>) as per actual requirement of the hospital.
- 2. The bidder has to submit bid for a period of 36 months.
- 3. L-1/successful bidder will be calculated on the lowest amount of total cost of the project as mentioned above at 'l'.

- 4. It must be noted that the rates quoted above shall be inclusive of wages component (minimum wages, plus ESI, bonus etc., as applicable), administrative cost, Hardware cost, Govt.fee, service charges, taxes etc. Except *revision of minimum wages rates of DEOs, as per orders of Labour Deptt of Govt. of NCT of Delhi, issued from time to time, No payment on any account, i.e. Govt. fee, taxes etc. shall be payable to the contractor.
- 5. No pro-rata increase in service charge component shall be allowed during period of contract. The quoted price shall be firm and final and no revision shall be allowed during the contract period on any grounds.
- 6. The payment to the contractor shall be made on the basis of their successful bidding amount only.
- 7. The price bid is also required to be attached in PDF format with financial bid.
